Melia Hayden: Husband and I bought a drink from a local Tatum eatery in November 2021. Few hours later, he became sick from drinking. They found in the drink what looked like rat poison to them. They went to the ER that night and filed a police report the next day. They were told to contact the health dept of Rusk County. Later that week they called health dept themselves. They said that PD never called the Health Dept. Back. Called 2 to 3 times a week. They were told that they could not find a lab to test it, no updates. The Haden's went public on FB, people came forward PD pushed case to the side and covered it up. Several days later they asked to print e force logs. Received logs that were touched few days later and not touched for weeks.

- Paloma Rioz: Bradford: Admiral William McRaven quote. Make your bed. Alleges that Parker Sweeney and Kenneth Jones assaulted wife and tazed them during a call. All charges dropped. Who hires the cops? Wanted money back for bail.
- Benoit: Why terminate? What grounds, explicit photos sent and taken out of context. Harassment, hostile work environment
